Sir/Madam,

It has reference to your proposal regarding granting extension of provisional affiliation for the session 2014-15 to your institute for B. Ed. course.

On the basis of the report of the Inspection team (which visited your institute on 14-06-2014) and as per the recommendations of various statutory bodies of the university, your institute is granted the extension of provisional affiliation (for one year) for the academic session 2014-15 for B. Ed. course with 100 seats to Aryabhatta Knowledge University, Patna on the following terms & conditions:-

1. The extension of provisional affiliation is presently for one year only for the academic session 2014-15.
2. The extension of provisional affiliation is based upon the approval accorded to your institute by the NCTE vide letter no. ERC/7-125.6(i).13/2011/8903 dated 14th October 2011.
3. The extension of provisional affiliation is granted for Bachelor of Education (B. Ed.) course and with an upper limit of intake of 100 students.
4. This extension of provisional affiliation is subjected to your attending to all the deficiencies pointed out by the Inspection team in its report dated 14-06-2014 within a period of 15 days from the date of issue of this letter. Deficiencies are as follow:
 - a. Faculty should be upgraded through proper training.
 - b. The payment of salary should be through account payee cheque or advice to the bank instead of payment through bearer cheque.
 - c. Biological and physical resource centre should be separately established.
 - d. The college should submit the annual performance appraisal report to the NCTE every year.
 - e. No. of computer should be increased from 08 to 25.
5. Further you have to inform the university through affidavit that you have removed all the deficiencies as intimated to you vide "4" above, failing which the extension of provisional affiliation, accorded through this letter, shall be deemed to have been automatically withdrawn.

6. On receipt of the affidavit, as mentioned at "5" above, the university shall send a surprise inspection team to your institution.
7. The extension of provisional affiliation shall be deemed valid only after the satisfactory report of the surprise inspection.
8. This affiliation is subject to the condition of deposit of Affiliation fees which must be deposited within a week from the date of receipt of this letter, failing which this letter will be automatically treated as withdrawn. In such a case no further correspondence shall be entertained.
9. Rules/regulations, etc. regarding syllabus, conduct of examination etc. shall be communicated after all the conditions for extension of provisional affiliations are met with by your institute to the full satisfaction of the University.
